Administration:

May 2017 meeting minutes approved (Jim Bullock motion, Joe Thome second)

ACA Presentation:

Terri Hurst from the Colorado Criminal Justice Reform Coalition presented to the Board on Health First Colorado and Take Care Health Matters, and the CTB ACA subcommittee. She reviewed client eligibility, enrollment in various agencies, and access to case. Relevant state legislation was reviewed and the future landscape with federal legislation pending. The CTB had an ACA subcommittee that met three times between October 2015 and the spring of 2016. The subcommittee was charged with taking a system wide look at effective use of CTB and Medicaid resources.

The Board decided to see if major changes in federal legislation are passed prior to the next CTB before making a decision about the ACA subcommittee.

CCJC conference update:

The Colorado Collaborative Justice Conference was held May 31-June 2nd and was the largest event thus far. There were over 902 people registered, 108 presenters, 32 conference staff and moderators, and 18 Correctional Treatment Board and Problem Solving Advisory Committee Members. Next year, CCJC will be held at the same location, Marriott Denver Tech Center, from May 2-4, 2018. An invite for the 2018 conference will be sent to Board Members via email.
