



Ekkewe 91 ran ra poputa atun ami angangfengen le atoura ewe Taropween Tingor, are atun pwuluom a angei ekkewe taropween alluk sennuk (served) ika epwe sain ewe taropween likitaalo (waiver).

- KOSAP amomo, amweta, tiinaalo, aea le parro, aopa, ika poutalo pisekimi nge ese wor mumutaan pulowom we are ewe leenien kapwung. Kopwe tongeni aea peioffimi fanniten bisines me le atufichi manawemi alon eoreniemi.
- KOSAP atai kinamween pwuluom we.
- KOSAP awesi, kaulo om kopwe monatiw, ika fori ekkiswil ngeni insurens lon pekin medical, imw, renter, waa, are manaw mi weneiti ngeni chon ei case. **Chilon Chok:** Kopwe tongeni fori ekkoch siwil ngeni insurens ren echo taropween mumu seni pwuluom we, ika court order.
