ACCEPTING FILINGS OVER COUNTER OR BY EMAIL

The Clerks Offices of the 14th Judicial District will accept filings over the counter or by email for 14th District court cases from all parties not required to use Colorado Courts E-Filing. Documents other than Motion for New Attorney Appointment will not be accepted from parties represented by an attorney. Filings from incarcerated parties represented by an attorney will be forwarded to that attorney and not added to the Court's case file. For information concerning filing documents by e-mail, see Chief Judge Order 22-08.

Documents must be in an acceptable form and will be rejected for filing for the following reasons:
