a) Legislation Updates (updated)

(Bill Effective Date)

Below is a list of some legislation going into effect and a summary of form changes.

Note: While the goal is to publish forms on the bill's live date, due to volume, new approval procedures, and accessibility remediation time, it may take several weeks/months for the updated form to be published. The outdated version of the form may be unavailable until then.

- HB25-1159 – Child Support Commission Updates May 31st, 2025
 - The domestic relations (DR) cover sheet is sealed after filing.
 - Updates to DR cover sheet, return/waiver of service, and response forms are coming soon. (estimated January 2026)
- HB25-1159 – Child Support Commission Updates March 1st, 2026
 - Updates to how child support is calculated.
 - *JDF 1820 – Support Worksheet A* will be discontinued.
 - JDF 1821 – will be renamed to just “Support Worksheet” and is being amended to accommodate new calculations.
 - *JDF 1822 – Child Support Guidelines* will be discontinued.
- HB25-1275 – Forensic Science Integrity June 2nd, 2025
 - DA will send a Notice to Defendants when crime lab misconduct is under investigation and after the final report is issued.
 - Creates a new process: Petition for Post-Conviction Relief.
 - Defendant has a right to counsel for the request.
