That *(name)* _____ and *(name)* _____ are or were married to each other and the child was born during the marriage, within three hundred days after the marriage was terminated by death, annulment, declaration of invalidity of marriage, dissolution of marriage, or divorce, or after a decree of legal separation was entered by a court.

4. That before the child's birth, *(name)* _____ and *(name)* _____ attempted to marry each other by a

marriage solemnized in apparent compliance with the law, although the attempted marriage is or could be declared invalid, **And:**

The attempted marriage could be declared invalid only by a court and the child was born during the attempted marriage or within three hundred days after its termination by death, annulment, declaration of invalidity of marriage, dissolution of marriage, or divorce.

Or

The attempted marriage is invalid without a court order and the child was born within three hundred days after the termination of cohabitation.
