

ELEVENTH JUDICIAL DISTRICT, STATE OF COLORADO
OVERVIEW
January 2026

The Eleventh Judicial District provides court services from four different courthouses in the district: Salida in Chaffee County, Westcliffe in Custer County, Cañon City in Fremont County, and Fairplay in Park County. (The Probation Department also has an office in Bailey in Park County.) The population of the district is approximately 96,033 people based on the 2024 census. The population has increased in every county over the past several years within each of the respective counties in the district.

There are four district court judges handling a mixed caseload of felony criminal matters, civil cases, probate, mental health matters, county court appeals, and juvenile and domestic relation cases not assigned to magistrates. The primary offices for the district judges are as follows: Two are in Fremont County, one in Chaffee County and one in Park County. One of the Fremont County district judges also currently handles an additional caseload in Custer County. All Judicial Officer's within the district may also handle individual cases in all the four counties as needed.

There is one county court judge in each of the four respective counties. The judge in Fremont County is full-time. The county court judges in Chaffee, Custer and Park Counties are all part-time. Their schedule is based upon the caseload for their respective county. The county courts handle traffic related matters, criminal misdemeanors, civil and small claims cases.

Our district has two full-time and three part-time magistrates. Three magistrates primarily serve in Fremont County. The magistrates handle a variety of juvenile, domestic relations, civil and other cases as assigned by the Chief Judge. Both part-time magistrates primarily serve in Chaffee County but have dockets and cases in the other counties as well in the judicial district.

In addition to the judges and magistrates, there are 47 court employees. These positions include Clerks of Court, Judicial Clerks, administrative staff, a Jury Commissioner, Collections Investigators, a Problem-Solving Court Coordinator, Family Court Facilitators, Self-Represented Litigant Coordinators, and Legal Research Attorneys. The district also employs 27 Probation employees.
