SUPREME COURT OF COLORADO OFFICE OF THE CHIEF JUSTICE ORDER

Concerning the Establishment of the Water Court Committee of the Colorado Supreme Court

I hereby constitute a standing Water Court Committee of the Colorado Supreme Court. Its charge is to work with the Water Judges, the State Court Administrator's Office, the members of the Colorado Supreme Court, the General Assembly, the Governor's Office, other public agencies having water responsibilities, and interested organizations and members of the public on matters concerning Colorado's water courts.

These matters include, but are not limited to, the recommendations contained in the report of August 1, 2008 submitted to me by the predecessor committee I established by order of December 4, 2007. The purpose of the Water Court Committee shall not include altering or impairing the existing water use rights of any public agency or private person.

I appoint Justice Greg Hobbs to chair the committee. Additional members of the committee will consist of an active water judge, two water referees, another justice of the supreme court, the state court administrator or designee, a senior water judge, the designee of the attorney general, the deputy for water of the department of natural resources, the state engineer, a division engineer, the director of the water conservation board, two persons who own and use water rights, two practicing water engineers, and six attorneys who have substantial experience in the water courts of the State of Colorado, one of whom shall represent the Water Section of the Colorado Bar Association. The members of the committee shall be appointed from time to time by the Chief Justice.

I appoint the following persons as the initial members of the Water Court Committee, with staggered terms all commencing August 15, 2008, so that a full term on the committee will be three years subject to reappointment:
