#### Administration:

### Budget Update:

#### Local Board Projects:

- Revision to the Annual State Funding Applications-Data Compliance:
  - The Board members approved the addition of the data reporting information to the decision item template for the annual State Agency Funding Request.

## Research Project to Study Treatment Outcomes

- Qualitative Study RFP Scope of Work Draft
  - Michelle provided a scope of work draft and shared the scope needed to be narrowed into two areas of focus to study the impact of CTB funds; Access/Availability and Impact/Effectiveness of treatment services. It was suggested to start with Access/Availability to provide foundation for a follow-up study on Impact/Effectiveness of services.
  - Board discussed and decided they would like to study both areas of focus, however at this time prioritized starting with Access/Availability.
  - Michelle will follow up on procurement options knowing the intent is for the Board to do a two-part study on the impact of the cash funds.
