Administration:

- September meeting minutes were approved. No objections.

Budget Update:

- The budget was reviewed for year-to-date spending.
- The hotel cancellation was paid out of the overhead budget line.
- Judicial has a new fiscal coding procedure and will be seeing transfer requests to the CTB Budget later than usual in previous years. Judicial does intend to use the full amount awarded.

Research Project to Study Treatment Outcomes:

- Michelle provided an update on the ad hoc group members. Once all members have been identified a meeting schedule at the start of the new year (2022). The ad hoc members will provide support in identifying objectives and scope of work with the Board's guidance for the qualitative study of treatment outcomes for the Correctional Treatment Board-funded services.

Discuss 18-19-103 Eligible Funded Services:

- This item was moved to December's agenda.

Revision to the Annual State Funding Applications-Data Compliance:

- Discussion held around initial steps to updating or creating new application templates for both the State Agencies and the Local Board Applications. The Board will start to examine the application process for the State-Funded Agency and Local Board applications for the FY2024 budget and Funding Plan.

Recovery Support Services-Contingency Management:

- The members decided that adding contingency management to the scope of recovery support services may be outside of the eligible services under the statute. While some of the services can overlap; the members felt the funds should focus on reducing barriers that can interfere with treatment and recovery. The Board approved the current Recovery Support Services with today's revision date.

December Meeting Agenda Request:

- Joe offered to present to the Board information on the Governor's Budget-The Executive Branch's plan to join into building safer communities. He will also share Colorado's crime trends.
