CCJC Update: Reminder to the CTB that the May meeting will be over the lunch period on Wednesday, May 2nd. The CTB agreed to attend the JBBS evaluation session prior to the lunch meeting and then has invited the JBBS evaluators to come to the May meeting to further discuss the project evaluation.

Budget Update: The budget update for FY18 shows spending on target for this time of year.

Funding Application Pilot Project: The CTB voted to fund the FY19 request for 18th/Douglas county Pilot Project, and have asked for more details on one section of the application. The CTB voted to fund the 7th Judicial District Pilot Project request in 2019, up to an amount the budget will allow. Board members were updated as to the status of active local boards which include the following Judicial Districts: 14th, 22nd, 18th, 12th, 7th, and 1st. The CTB voted to extend the deadline for the FY2020 process to June 1st 2018.

Christy Donner from CCJRC presented to the CTB regarding the background, process and details regarding HB18-1176, which proposes transferring a large portion of funding out of the CTCF to the DOC budget for a re-entry program in FY19. The CTB was in agreement that the process and communication was not ideal, but accept the outcome.
