MINUTES April 18, 2017

Administration:

March 2017 meeting minutes approved (Jim motion, Eileen second)

The Board approved the list of FY18 meeting dates. The Board discussed the start and end time for the meetings and decided to change the meeting to begin at 1:00pm and end at 3:00pm beginning May 16, 2017.

The May meeting will occur on May 16, 2017 as previously scheduled.

The Board decided to continue posting the Meeting Agenda one week in advance of each scheduled meeting on the CTB website.

CCJC conference update

Conference registration has closed, and the conference planning team is working on continuing to register people on the waitlist. Registration is currently at about 870 people. The Board had a discussion about how to encourage and enhance the completion of attendee session surveys, including asking about how attendees are applying what they learned post-conference. The conference will be in the same venue with similar capacity in 2018; however there is room for discussion about conference growth beginning in 2019.

Board Discussion

The Board members discussed the timing and status of the CAM project. The data analysis is in progress. The various agencies involved in CAM need to have time to discuss the analysis and findings, and then take the next step of policy discussions. However, the results of the evaluation that the Board funded can be presented in an upcoming meeting. The board agreed that this presentation should happen sooner than later but a specific time could be determined once the agencies are able to discuss the analysis of the data.

The Board discussed re-appropriations with respect to a provider rate change in the Community Corrections systems. Each agency's respective budget and JBC offices are aware of the change.

Program Updates

OBH will present on the data gathered on the JBBS program at the May meeting, and the PSC evaluation and ACA update will be on the June agenda. A date for the CAM evaluation will be set once the agencies have had the opportunity to review the data analysis.
