Administration:

July 2017 meeting minutes were approved (Eileen Kinney motion, Jim Bullock second).

Problem Solving Court Evaluation:

Amy Kingery presented an update on the 2017 Problem Solving Court (PSC) Evaluation which is partially funded by the Board. The Ten Key Components of Drug Courts, general national research on Drug Courts and the 2012 Statewide Process Assessment and Outcome Evaluation was reviewed. The 2017 Colorado Statewide PSC Process Assessment, Outcome Evaluation & Cost/Benefit Analysis started in 2016. Many steps of the process have been completed, including data gathering and choosing sites for Cost/Benefit Analysis. The next steps include ongoing work with the data, collaborating with the Office of Behavioral Health, completing the analysis in January 2018 and the final report in April 2018.

Colorado Collaborative Justice Conference Update:

All session evaluations have been pulled out of the conference application and reviewed. The planning committee has been integrating feedback into the conference plans for 2018. Feedback will be delivered to presenters later this month. The planning committee is in the final stages of choosing a hotel venue for the 2019/2020 conference, and has narrowed the options to two hotels.

Budget Update/Funding Application:

The Board was provided the monthly budget update. Final fiscal year budget figures should be available in September. The Board was provided the newest draft of the Funding Application Process. The Board is considering creating a limited number of pilot projects to test the funding application in preparation for the process being ready for the FY2020 funding plan, and will discuss this further at the September meeting.

Misc:

A guest in attendance, Cynthia Hoskins Koenck, asked a question about the status of a treatment provider's license. Her question was unrelated to the business of the board and she was given information to assist in her in communicating with the proper agency.
