FY18 Funding Plan & Narrative

Agency requests are the same request from the previous year with the exception of the \$50,000 request for additional funds for the CCJC conference to support new drug court team and staff coming onboard in this fiscal year. Brenidy indicated that for this year, juvenile drug court teams will attend the Convening Conference for Children Youth and Families as the content may be a better fit. The board agreed the funds would come out of the overheard balance and be applied to the PSC budget, which we've been encouraged to spend down. The CCJC conference does not charge any registration fee, 750- 780 conference attendees and presenters on average, currently, they are expecting 800 Colorado criminal justice and mental health professionals to attend this year. The overall conference budget will remain the same.

Regarding all agency funding requests for FY18, the Board has consensus on the agency requests- all are the same from FY17.

The board confirmed the two subcommittees that exist and the evaluations for the JBBS and Problem solving courts. The board has contributed funds to support the evaluations.
