Jeanne moved to approve minutes with a second from Deborah. Minutes were approved.

8th Judicial District Local Board Visit

The local treatment board from the 8th Judicial District, Larimer and Jackson Counties, came for a visit. The group reviewed the service map for the district and minimal updates were made. The district has sufficient outpatient, community corrections, Parole and JBBS services in Larimer County. Jackson County has clients in need of services. Parole and Probation travel out there for supervision, but clients needing treatment generally have to travel to other locations to receive it.

The local board updated the statewide board on its need for post-sentencing housing for high-risk/high-need clients with mental health and addiction issues. This population is growing and the need for stable transitional housing is high. The local board has two options for developing a housing facility and needs funding resources to make it happen. The hope is that the Correctional Treatment Board can help. Larimer County has been progressive with its alternative sentencing and between the Wellness Court and Drug Court; the board estimates almost 100 clients throughout the year could use a housing resource if it existed. It would help with stability, sobriety and other transitional/treatment needs. The ultimate goal is to get the client stable, get them treatment and have the goal be to move into a Sober Living environment or transition successfully back into the community. It is estimated that a client would stay in this housing resource between 2 weeks and 4 months. The estimated annual cost would be about \$450,000.

The statewide board indicated that currently there is no mechanism to funnel money to local boards and with the current allocation, any funding of such a project would require a reduction in other funded services. The statewide board asked if the local board had any supporting data regarding housing that it could use to help justify future requests for increased funding. The local board will gather what it has and communicate that to the statewide board. The statewide Board will be discussing its FY2017 funding plan over the next few months and will include creative ways to help local boards develop programs/services to fill in gaps.
