#### Administration

- Eric moved to approve minutes with a second from Jeanne. Minutes were approved.
- Tia reminded the Board of the need for each state agency representative on the Board to discuss FY2014 spending and have overages/surpluses reported back to her by March 11<sup>th</sup> so reallocations can be discussed at the March Meeting.
- Tia updated the Board on the fact that Kelly Messamore will not be at the February and March meetings and Barry Pardus will be representing DOC in her absence.

#### **Local Board Visit**

The local treatment board from the 13<sup>th</sup> Judicial District (NE corner of the state) was present to discuss and exchange information on issues it is facing, priorities it has for funding and other matters. The Treatment Resource Continuum was used as a framework and the use of assessments, treatment resources and other programming was discussed. A separate 13<sup>th</sup> Treatment Board summary document has been prepared for the board's review.

# **IRT for Probation**

A discussion was had about the development of IRT programs for probation. At least four probation offices are in discussions with their community corrections providers about expanding the capacity at the comcor facility to include IRT for probation. The Board discussed its long-term goals/plans for the IRT expansion. DCJ can't expand IRT beyond its existing contracted providers and they won't work to expand capacity without data that supports the assessed need for IRT. DCJ has two more years on its current IRT contract and will re-bid for FY2017. The Board discussed its goals in supporting IRT expansion outside of the contracted entities until DCJ can officially re-bid. Probation offices cannot use probation resources to pay for Parole IRT needs. If parole has a need for IRT beds, they must use DOC resources to cover the cost. The immediate goal is to get the probation offices using a contract that includes existing DCJ language and have providers enter comcor data directly into DCJ's system. This will create consistency in data collection as well as help transition any providers who enter into a contract with DCJ in the 2017 IRT re-bid.

Glenn Tapia provided an update on the use of CTCF that support IRT and Treatment vouchers.
