Administration

- Jim moved to approve minutes with a second from Brian. Minutes were approved.
- Christie Donner presented on an ACA/CJ website that she is developing and solicited input from the Board as to information it would like to see as well as convey. Feedback was provided. Dave will get Christie connected to the Colorado Jail Association. The website hopes to launch by mid-November.

Financial

An FY2014 final update was provided. The cash fund balance grew to \$2.7M (19.7%) due mostly to an underspending by the Judicial Department. OBH program managers indicated the JBBS program would underspend, yet the Department of Human Services used its full CTCF allocation. This issue will be researched once CORE gets up and running. The Board will follow-up regarding Judicial underspending and other stated needs: ATR grant expiration, JBBS continuity of care funding, PSC, Parole and others.

The Board discussed the FY2016 allocation. There is just over \$175,000 left to allocate due to a reduction in the request by the Judicial Department. The Board wants more information in September before determine if/where to allocate these funds.

A request for \$4,000 in overhead funding was made. DCJ and Judicial are making a series of LSI training videos for use across the criminal justice system. The Board voted and approved funding from the overhead account for this purpose.

4th Judicial District Local Board Visit

The local treatment board from the 4th Judicial District (El Paso and Teller Counties) was present to discuss and exchange information on issues it is facing, priorities it has for funding and other matters. A separate 4th Treatment Board summary document has been prepared for the board's review.
