Legal Description: Located whence the North Quarter Corner of Section 28, Township 13 South, Range 96 West of the 6th P.M. bears North 54° West 960 feet. (See Exhibit A location map.) Source: Doughspoon Creek, a tributary of Forked Tongue Creek, a tributary of the Gunnison River. Date of appropriation: July 25, 1947. Amount: 23.7 acre-feet; of which 9.4 acre-feet is decreed absolute and 14.3 acre-feet is decreed conditional. Uses: Municipal uses. Remarks: The Delta City Reservoir No. 1 has two separate rights decreed to it: The Delta City Reservoir No. 1 Enlargement water right was first decreed in CA3503 on March 20, 1954 in the amount of 14.3 acre-feet and was made absolute in Case No. 02CW51. The Delta City Reservoir No. 1 water right was first decreed in Case No. 02CW51, with an adjudication date of December 31, 2003, in the amount of 23.7 acre-feet (9.4 acre-feet absolute and 14.3 acre-feet conditional). This Application involves the conditional portion (14.3 acre-feet) of the Delta City Reservoir No. 1 water right. Integrated System. Pursuant to decree entered in Case No. 2016CW3021, the Delta City Reservoir No. 1 water right is part of an integrated water supply system to provide municipal water supplies to the City of Delta. Thus, work on one feature of the municipal water supply system shall be considered in finding that reasonable diligence has been shown in the development of water rights for all features of the system. C.R.S. § 37-92-301(4)(b). Claim for Finding of Reasonable Diligence. A detailed outline of what has been done toward or for completion of the appropriation and application of water to beneficial use as conditionally decreed, including expenditures, is included in the Application. Name and address of the owner of land on which the subject water right is located and on which water is/will be used: The Delta City Reservoir No. 1 is located on U.S. Forest Service lands: Forest Supervisor, Grand Mesa Uncompahgre and Gunnison National Forests, USDA Forest Service, 2250 South Main Street, Delta, CO 81416. Applicant is the owner of the municipal water distribution system by which the subject water right is and will be put to beneficial use. Applicant requests the Court to determine, adjudge, and decree that the Applicant has shown reasonable diligence in the development of the remaining conditional portion of the Delta City Reservoir No. 1 water right and continuing such conditional water right in full force and effect. **DELTA COUNTY.**

Location: In the NESE of Section 12, Township 14 South,

Name and Description of Conditional Water Rights.** (a) Name of Structures. (i) Double RL Spring No. 1 (WDID 6801209). (ii) Double RL Spring No. 2 (WDID 6801210). (b) Original and Subsequent Decrees. The original decree for the subject water rights was entered on February 8, 1988, *nunc pro tunc* to January 26, 1988, in Case No. 87CW195, Water Division 4. The conditional rights were continued by the diligence decrees entered on March 16, 1995, in Case No. 94CW16, Water Division 4, and on September 27, 2016, in Case No. 16CW3017, Water Division 4. (c) Legal Descriptions of Structures. The decreed legal descriptions for Double RL Spring Nos. 1 and 2 are set forth below. A map showing the location of the subject structures is attached hereto as **Exhibit A.** (i) Double RL Spring No. 1. Located in the SE1/4 of Section 5, Township 44 North, Range 9 West, N.M.P.M., Ouray County, Colorado, at a point from which the SW corner of said Section 5 bears South 50°08'42" West 3,827.44 feet. (Zone 13, NAD83, Easting 247404.8m, Northing 4220151.7m.) (ii) Double RL Spring No. 2. Located in the NE1/4 of Section 8, Township 44 North, Range 9 West, N.M.P.M., Ouray County, Colorado, at a point from which the NW corner of said Section 8 bears North 82°57'11" West 2,733.87 feet. (Zone 13, NAD83, Easting 247447.6m, Northing 2419367.9m.) (d) Source. Said springs are tributary to Cottonwood Creek, Dallas Creek, and the Uncompahgre River. (e) Date of Appropriation. April 1, 1982, for both springs. (f) Amounts and Uses. (i) Double RL Spring No. 1. 5 gpm, for stockwatering and irrigation. (ii) Double RL Spring No. 2. 10 gpm, for stockwatering and irrigation. (g) Remarks. There are minor discrepancies between the decreed and actual locations of the Double RL Spring Nos. 1 and 2, as well as the locations of the structures as currently shown in DWR MapViewer. The UTM coordinates for the actual location of the structures as recently field verified by Applicant is set forth above. Applicant requests that the DWR records be updated to reflect the identified location of the structures. **3. Claim for Finding of Reasonable Diligence.** The following activities were undertaken since the last diligence finding in order to complete and apply the subject conditional water rights to their decreed beneficial uses: (a) Water Resources Engineering Activities. Applicant's water resource and water rights engineers, BBA Water Consultants, Inc. ("BBA"), performed a site visit to the Double RL Spring Nos. 1 and 2 on September 15 and 16, 2022. The site visit was part of BBA's ongoing efforts to assist with the development of the spring sites. (b) Measuring and Recording

Devices. During the subject diligence period, Applicant installed a 45-degree V-notch weir at the Double RL Spring No. 1. Applicant can now measure and record the use of Double RL Spring No. 1 so that the conditional right can be made absolute. Applicant also acquired a 45-degree V-notch weir for installation at the Double RL Spring No. 2; however, due to low flows at the spring this year, the weir was installed elsewhere. Applicant intends to install a different weir at Double RL Spring No. 2 soon. (c) General Legal and Engineering Costs. Applicant has also incurred general legal and engineering costs during the subject diligence period in performing accounting and other water rights related work and in monitoring, evaluating, and participating in water rights cases and other related projects in order to protect its water rights against injury. **4. Cancellation of Domestic Use.** Applicant does not seek to continue the domestic use for the Double RL Spring Nos. 1 and 2. Accordingly, the decreed use of domestic can be cancelled for both rights. **5. Name and Address of Landowner upon which any New or Modified Diversion or Storage Structure is Located, Including Any Modification to the Storage Pool.** All of the subject structures are located on land owned by Applicant.
