Order re: Access by Court Appointed Special Advocate

The Court finds that Court Appointed Special Advocates, Child's Representatives (CRS 14-10-116) and Guardians ad Litem may need access to the records of the 22^{nd} Judicial District Probation Department.

The Court finds that in order to provide the Court with information needed to determine the best interests of children in Dependency and Neglect, Dissolution and Allocation of Parenting Time cases, including parenting time disputes, that Guardians ad Litem, Child's Representatives and Court Appointed Special Advocates shall be granted access to the records of the 22nd Judicial District Probation Department.

The order appointing the Child Representative, Court Appointed Special Advocate or Guardian ad Litem must be provided to the Probation Department. The Guardian ad Litem, Child's Representative or Court Appointed Special Advocate is bound by all rules of confidentiality, including the Federal Standards related to mental health, drug and alcohol treatment information. The person whose records are sought for review shall be notified of such review by the Court Appointed Special Advocate, the Guardian ad Litem and the Child's Representative, if possible, the, Court Appointed Special Advocate or Guardian ad Litem shall obtain a release from the person who records are sought to be reviewed on the probation approved form.
