NOTICE OF SUPPLEMENT TO PRODUCTION BY THE COLORADO MENTAL HEALTH INSTITUTE AT PUEBLO IN RESPONSE TO THE PEOPLE'S SUBPOENA FOR PRODUCTION OF TANGIBLE EVIDENCE

The Colorado Department of Human Services (the "Department") and the Colorado Mental Health Institute at Pueblo ("CMHIP"), through the Office of the Attorney General, respectfully provides notice of its supplement to production of records already produced in compliance with the People's April 4, 2016 Subpoena for Production of Tangible Evidence and this Court's Order re: (P-011) Motion for Discovery and Disclosure of Medical and Mental Health Documents; Discovery of and Disclosure of Expert Opinions Relating to the Issue of the Defendant's Competency; Request for Production of the Documents in Advance of the Hearing; Request for Subpoena Duces Tecum Date Prior to the Hearing; and Request for

Notice of Witnesses Intended to be Called at the April 28, 2016 Hearing, and states as follows:

### PROCEDURAL HISTORY AND NOTICE

- 1. On April 4, 2016, the People served the Colorado Mental Health Institute at Pueblo (CMHIP) with a Subpoena for Production of Tangible Evidence. At the same time, they provided CMHIP with a copy of this Court's April 1, 2016 Order re: (P-011) Motion for Discovery and Disclosure of Medical and Mental Health Documents; Discovery of and Disclosure of Expert Opinions Relating to the Issue of the Defendant's Competency; Request for Production of the Documents in Advance of the Hearing; Request for Subpoena Duces Tecum Date Prior to the Hearing; and Request for Notice of Witnesses Intended to be Called at the April 28, 2016 Hearing (Order).
- 2. CMHIP notified undersigned counsel of receipt of the Subpoena and Order on Thursday, April 7, 2016. According to the Subpoena and Order, the original return date on CMHIP's production was set for April 11, 2016.
- 3. On Friday, April 8, 2016, undersigned counsel contacted this Court's clerk regarding a brief extension of time to produce responsive documents.
- 4. Neither the People nor defense counsel objected to an extension. On Monday, April 11, 2016, the Court entered a minute order resetting the Subpoena return date for Friday, April 15, 2016 at 9:00 a.m.
- 5. CMHIP representatives appeared on Friday, April 15, 2016, and produced documents responsive to the Subpoena, as ordered.
- 6. On Monday, April 25, 2016, undersigned counsel received a voicemail message from the People, inquiring as to the completeness of CMHIP's April 15th production. In particular, the district attorney inquired as to whether notes from Dr. Thomas Gray and Dr. Jackie Grimmett were missing from the production.
- 7. Undersigned counsel immediately contacted CMHIP to address this inquiry. Upon conferral, undersigned counsel learned that both Drs. Gray and Grimmett's notes had been unintentionally omitted from the documents delivered by CMHIP on April 15, 2016.
- 8. Accordingly, CMHIP now supplements its April 15, 2016 production with the documents previously inadvertently omitted. These documents are

responsive to the Subpoena and the Order. They were not omitted due to any assertion of privilege by CMHIP, nor does CMHIP contend that they are subject to an *in camera* review before dissemination to the parties. They were not produced earlier only due to inadvertence and miscommunication.

WHEREFORE, the Colorado Department of Human Services and the Colorado Mental Health Institute at Pueblo respectfully provides notice of its supplement to production of records.
