Description of the Conditional Appropriative Right of Exchange. A. Name of Conditional Appropriative Right of Exchange. Blue Mesa Reservoir – Excelsior Ponds Exchange (the “Exchange”). B. Prior Decrees: The original decree adjudicating the Exchange was entered on May 28, 2009, in Case No. 07CW211, by the District Court, Water Division No. 4, State of Colorado. Diligence has been maintained for the Exchange by decree of the District Court for Water Division No. 4 entered in Case No. 15CW3032 on October 19, 2015. C. Legal Description: The description of the exchange reach is from Blue Mesa Reservoir up the Gunnison River to Almont, thence up the Taylor River to the confluence with Excelsior Creek, and thence up Excelsior Creek to Excelsior Pond located within the NW1/4SW1/4 Section 9, Township 15 South, Range 83 West, 6th P.M. The outlet for Excelsior Pond is located at a point 489 feet east of the west section line and 2594 feet north of the south section line. D. Description of Exchange: Water will be released from Blue Mesa Reservoir at the direction of the Division Engineer and exchanged up the Gunnison River, the Taylor River, and Excelsior Creek to the named structure. E. Appropriation Date: December 28, 2007. F. Amount: 0.002 c.f.s., conditional. G. Use: Augmentation of Excelsior Pond for recreational, piscatorial and fire protection. 3.
