AFFIDAVIT FOR ARREST WARRANT

Your Affiant, Detective John Sailer (hereafter referred to as I) is a duly commissioned peace officer with the City of Boulder Police Department located in the County of Boulder, State of Colorado, being duly sworn, deposes and states:

I am currently assigned to the Detective Section of the Boulder Police Department and investigate crimes occurring within the City of Boulder, County of Boulder, State of Colorado. The associated Boulder Police Department case number is 25-5040.

On 06/01/2025, I was assigned to assist with this case (25-5040). I reviewed emergency dispatch notes regarding an ongoing arson/mass casualty incident which took place in the area of the Boulder Courthouse, 1325 Pearl St, in the City and County of Boulder, State of Colorado.

At approximately 1327 hours, Officers were dispatched to a report of a male suspect with a "blow torch" setting people on fire. The suspect was then described as throwing "Molotov cocktails" at multiple people. The suspect was described as a white male, wearing no shirt, jeans, sunglasses, and with gray hair. Officers arrived at 1325 Pearl St, at 1330 hours. Upon arrival, witnesses were pointing at a shirtless male who was standing in the grass facing the crowd and yelling. This male matched the description previously given by witnesses. At approximately 1332 hours, Officers placed the suspect in custody, and incendiary devices were located within the suspect's arm reach. Multiple victims with serious injuries were evacuated by emergency medical personnel. The suspect was taken to Boulder Community Hospital (4747 Arapahoe Ave) for a medical clearance.

The suspect identified himself as Mohamed Sabry Soliman (DOB 12/15/1979). Medical personnel reported Mohamed as stating he undertook the attack as vengeance for "his people." Mohamed admitted to planning and carrying out this attack during an interview with law enforcement. He also indicated he left a phone and journal for his family at his house in Colorado Springs.

Mohamed has a valid Colorado driver's license, from which I obtained his identifying information. He has no NCIC criminal history. His driver's license also included his address as [REDACTED] Washo Cir, Colorado Springs, Colorado. Colorado DMV records indicated his vehicle as a silver 2015 Toyota Prius, with a Colorado license plate of [REDACTED]. The vehicle's registration is currently active. Officers located the vehicle in the 1300 block of Spruce St.

I later gathered further details regarding the incident. I learned from other Officers and witnesses that Mohamed had thrown at least one incendiary device, possibly two, at members of a pro-Israeli demonstration group, and possibly utilized a homemade blow torch as well. This pro-Israeli group has been conducting semi-weekly walks in the area of the Boulder Courthouse to memorialize victims and hostages of the October 7th attacks in Israel. Mohamed threw the incendiary devices into a crowd of people causing at least eight of those people to be burned or to catch on fire.

Victims and witnesses observed Mohamed throw what appeared to be a glass bottle, lit on fire, which burst upon impact, creating large flames. He also made use of a commercial weed sprayer. A witness, [REDACTED], observed Mohamed using the sprayer as a makeshift blowtorch, and thus believed the sprayer to contain some sort of fuel. Officers observed Mohamed's intact devices to be glass bottles filled

with a clear liquid and stuffed with a rag. Based upon witness statements of the flames caused by the devices bursting, bomb techs posit the clear liquid to be gasoline or a similar combustible fuel. Boulder County Regional Bomb Squad members responded due to the possibility of further incendiary and/or explosive devices. Det. Quayle utilized a protective bomb suit to clear Mohamed's Prius of possible hazards. Inside the vehicle, he observed what appeared to be cans of gasoline, rags, and a Quran.

The victims were identified to me as follows: [REDACTED]

[REDACTED] and the [REDACTED] were noted as having suffered particularly severe burns and were transported to the Denver area for critical treatment. All victims received burns from the flames caused by Mohamed's devices.

Det. Tuck interviewed Mohamed while he was being treated at the hospital. She later reported the following to me:

Mohamed was born in Egypt, lived in Kuwait for 17 years and moved to Colorado Springs three years ago. He moved to Colorado Springs with his wife and five kids. He provided an address of [REDACTED] Washo Circle in Colorado Springs, Colorado.

Mohamed had been planning this attack for the last year and was waiting for his oldest daughter to graduate from high school before completing the attack. She graduated last Thursday. Mohamed expressed his hatred for the Zionist Organization as they support and fund the bombings that are taking place in Palestine. He said he searched for Zionist groups and found the one in Boulder which advertised their weekly marches down Pearl Street Mall in Boulder, Colorado every week on Sundays. The marches are to remember Israeli hostages in Gaza. Mohamed said he knew where they were meeting and knew they were meeting at 1300 hours. Mohamed drove from Castle Rock where he purchase most of the materials needed to carry out his attack. He arrived in Boulder around 1250 and waited for them to gather near 13th and Pearl St.

Mohamed searched YouTube and learned how to make Molotov cocktails. Mohamed said he had to use Molotov cocktails after he was denied the purchase of a gun due to him not being a legal citizen. Mohamed said he took a concealed carry class where he learned to shoot a gun but that all changed after he was denied the purchase.

Mohamed said he wanted them to all die and that was the plan, he said he would go back and do it again and had no regret doing what he did. Mohamed said anyone who supports the exist of Israel on "our land" is Zionist. Mohamed clarified "our Land" was Palestine.

Mohamed said it was revenge as the Zionist group did not care about thousands of hostages from Palestine. He said they care about their benefit, money, and power. Mohamed said this had nothing to do with the Jewish community and was specific in the Zionist group supporting the killings of people on his land (Palestine).

Mohamed filled 8 glass containers he purchased from Target with gas, he put them in a black storage bin and in order to get as close as possible to the group he dressed himself like a gardener. He wore an orange vest, bought flowers from Home Depot in Castle Rock and purchased a backpack sprayer which he filled with gas


and wore on his back as he approached the group. He said he did not spray the gas on anyone but himself because he had planned on dying. Mohamed mentioned several times he wanted to be dead. Mohamed said he only threw two at the group because he got scared and had never hurt anyone before. He said he had to do it, he should do it, and he would not forgive himself if he did not do it. Mohamed said no one knew about his plans and he never talked to his wife or family about it. Mohamed described his hopes for everyone in the Zionist group to die.

After clearing the scene, evidence techs identified 18 separate incendiary devices, including the two which were ignited and thrown in the attack.

I believe that sufficient probable cause exists to believe that Mohamed Sabry Soliman with a date of birth of 12/15/1979, described as a White Male, 5'09" tall, 231 pounds with Black hair and Brown eyes, with a social security number of Unknown, committed the CRIMES OF CRS 18-3-102(1)(a); 18-2-101 First Degree Murder (after deliberation) - Criminal Attempt, CRS 18-3-102(1)(d); 18-2-101 First Degree Murder (extreme indifference) - Criminal Attempt, CRS 18-3-202(1)(a) First Degree Assault (at-risk victim), CRS 18-3-202(1)(a); 18-2-101 First Degree Assault, and CRS 18-12-109(4); 18-2-101 Possession of an Incendiary Device - Criminal Attempt, and CRS 18-12-109(4) Possession of an Incendiary Device.

I respectfully request that a warrant be issued for Mohamed Sabry Soliman with a date of birth of 12/15/1979, described as a White Male, 5'09" tall, 231 pounds with Black hair and Brown eyes, with a social security number of Unknown, for the CRIMES OF CRS 18-3-102(1)(a); 18-2-101 First Degree Murder (after deliberation) - Criminal Attempt, CRS 18-3-102(1)(d); 18-2-101 First Degree Murder (extreme indifference) - Criminal Attempt, CRS 18-3-202(1)(a) First Degree Assault (at-risk victim), CRS 18-3-202(1)(a); 18-2-101 First Degree Assault, and CRS 18-12-109(4); 18-2-101 Possession of an Incendiary Device - Criminal Attempt, and CRS 18-12-109(4) Possession of an Incendiary Device.
