a) Legislation Updates (new)

(Bill Effective Date)

Below is a list of some legislation going into effect and a summary of form changes.

Note: While the goal is to publish forms on the bill's live date, due to volume, new approval procedures, and accessibility remediation time, it may take several days/weeks for the updated form to be published. The outdated version of the form may be unavailable until then.

- HB25-1159 – Child Support Commission Updates May 31st
 - The domestic relations (DR) cover sheet is sealed after filing.
 - Updates to DR cover sheet, return/waiver of service, and response forms are coming soon.
- HB25-1058 & SB25-041 – Competency/Sanity August 6th
 - Coming soon, new form: JDF 2155 – Title TBD
 - Updates to JDFs 2130 (was 30), 2131 (was 31T), 2132 A (was 32T), 2132 B (was 32T(b)), and 2133 (was 33T) are coming soon (not on August 6th).
- HB25-1168 – Victim-Survivors in Evictions August 6th
 - Victim-survivors of certain crimes are given additional protections in residential eviction cases.
 - Updates to JDFs 91, 99A, 102, 107A, and 109 coming soon (not on August 6th).
 - JDFs 99A and 102 will be temporarily unavailable starting on August 6th.
 - Updates to JDFs 101 and 103 are coming later this year/early 2026.

- HB25-1204 – Colorado Indian Child Welfare Act
 - Codifies federal law protections into Colorado Statutes.
 - JDF 1352 – Order Re ICWA, update in development. Form will be moved from the public site to the Judicial Resource Manual (JRM).
 - New form JDF 1353 – Notice of Custody Proceedings (ICWA).
