1. Family Case

You (*the Respondent*) are now a part of a court case to resolve a family legal matter.

Along with this summons, you will get a document called a Petition. The Petition will let you know more about the case and what the Petitioner wants the Court to do.

Ren ei Taropween Koraato, epwe pwal wareituk echo Taropween Tingor. Ewe Taropween Tingor epwe affata ngonuk met ewe Chon Tingor a mochen ewe Leenien Kapwung an epwe fori.

2. Your Next Steps

Met Kopwele Fori

You must file a written response to that Petition.

Pokiten ka angei ena Taropween Tingor iwe a lamot kopwe polueni ren om makeetiw me atoura.

- a) You may use form *JDF 1015 – Response to the Petition*.

- c) Your response is **due within 21 days** of receiving this summons.

3. Consequences

Met Mwiriloon

If you do not file a Response, the Court may decide the case without your input. You may not receive further notice about court filings and events. You are still required to obey any orders the Court issues.

4. Automatic Court Orders *(Temporary Injunction)*

Kapwungun ewe Leenien Kapwung mi weneituk mwen apwungupwungun om case (Nge Esap Nomofoch)

As soon as you receive this Summons, you must obey these orders:

Lon ewe chok atun ka angei ei Tingor, kopwe alleasochisi ekkeei alluk:

- a) Do *not* sell, transfer, assign, borrow against, hide, or get rid of any marital property without permission of the other party or the court. You may use your income for your usual business expenses and life necessities.

KOSAP amomo, amweta, tiinaalo, aea le parro, aopa, ika poutalo pisekimi nge ese wor mumutaan puluwom we are ewe leenien kapwung. Kopwe tongeni aea peioffimi fanniten bisines me le atufichi manawemi alon eoreniemi.

- b) Do *not* disturb the peace of the other parent or parties in this case.

KOSAP atai kinamween ewe pwal emon sam ika in are ekkewe ekkoch lon ei case.

- c) Do *not* take the children out of the state without permission from the Court or the other party.

Atun ei case, ewe Leenien Kapwung are ewe pwal emon sam ika in iir chok repwe tongeni mwut ngonuk om kopwe uwei ekkewe nau ngeni pwal eu state.

- d) Do *not* stop paying, cancel, or make any changes to health, homeowner's, renter's, automobile, or life insurance policies that cover the children or a party in this case or that name a child or a party as a beneficiary.

KOSAP awesi, kaulo om kopwe monatiw, ika fori ekkiswil ngeni insurens lon pekin medical, imw, renter, waa, are manaw mi weneiti chon ei case.

Exception: You may change insurance coverage if you have written permission from the other parent or party or a court order and give at least 14 days' Notice to the other party. C.R.S. §§ 14-10-107, 108.

Chilon Chok: *Kopwe tongeni fori ekkoch siwil ngeni insurens ren echo taropween mumu seni pwuluom we, ika court order. Kopwe pwal awora Notice (echo taropween essissil) mwaren 14 ran ngeni pwuluom. C.R.S. §§ 14-10-107, 108.*

You must obey these orders until this case is finalized, dismissed, or the Court changes these orders. To request a change, you may use form *JDF 1314 – General Motion*.

Kopwe alleasochisi ekkeei alluk tori ewe fansoun ei case a wes ika musaalo are ewe Leenien Kapwung a siwili ekkeei alluk. Nounou JDF 1314 – General Motion an epwe tingor och siwil ngeni ekkeei alluk.

5. Note on Genetic Testing

Ika lo Semelapan

You can request genetic testing. The Court will not hold this request against you when deciding the case's outcome.

A mwut ngonuk om kopwe tingor genetic testing le silei io mi wesewesen ewe sam. Ewe Leenien Kapwung esap etipisuk pokiten om tingor atun ra fori ar angangan apwungupwung.

You must do testing and submit the results before the Court establishes who the parents are (*parentage*) and issues final orders. After that time, it may be too late to submit genetic testing evidence. The law that directs this process is C.R.S. § 14-10-124(3.5).
