# Guide to Convert a Legal Separation to a Divorce

### **General Information**

- This information provides a guide to the process and forms necessary to convert a Legal Separation to a Divorce.
- Your motion should be filed in the District Court where the Decree for Legal Separation was issued.
- You must wait a minimum of 182 days from the date of the Decree of Legal Separation before you can file your motion to convert.
- The law that directs this process is Colorado Revised Statutes (C.R.S.) section (§) 14-10-120(2).

# Step-By-Step

#### Step 1: Complete Forms

- 1) Motion to Convert (JDF 1321)
  - a) Please complete all sections of this form.

- b) If both parties agree to the conversation, they should both sign the form.
- c) If a party desires to have a prior name restored, that person must indicate that fact on the Motion.
- d) Complete the Certificate of Service at the bottom of the form if only one party signed the form.

### 2) Order to Convert (JDF 1322)

- a) Complete the caption only on this form.
- b) The Magistrate or Judge will complete the remaining sections of this Order and give you and the other party a signed copy.

#### 3) Decree (JDF 1019):

- a) Complete/mark all sections on this form consistent with your Decree for Legal Separation.
- b) If you or the Co-Petitioner/Respondent are requesting to have a name changed/restored, please identify the restored name you or the Co-Petitioner/Respondent are requesting.
- c) Provide the Court with the number of copies you would like. If you want any of the copies to be certified, you will need to provide the Court with a certified copy fee of \$20.00.

# Step 2: File with the Court

- 1) Pay the filing fee or request a fee waiver.
- 2) If your address has changed since you originally filed your case, please provide your current address to the Court in writing. Use form JDF 1312 Contact Information Change.
- 3) Provide the Court with a self-addressed stamped envelope for each party to receive a copy of the Decree. If e-filed, self-addressed stamped envelopes may not be required.

#### Step 3: Service

Skip this step if both parties signed the motion.

If only one party signed the Motion, then you must provide a copy to the other party. You can serve this Motion on the same day that you file it with the Court.

### Step 4: Response

Skip this step if both parties signed the motion.

- 1) As the responding party, you have 21 days to file a response.
- 2) Let the court know if you want to have your prior name restored in the response.
- 3) No specific response form exists for this process. However, you can use form *JDF 1315 General Response*.

#### Step 5: Court Decision

The Judge or Magistrate will review the Motion and any Response filed. If approved, the Court will sign the Order to Convert the Legal Separation to a Divorce.
