FISCAL YEAR 2026 PERFORMANCE PLAN

The legitimacy of government depends on the fair, impartial, and reliable administration of the laws. Courts serve the people of the state by resolving disputes, protecting individual rights and the public interest, and delivering justice in criminal and civil cases. To ensure a just society, courts must tailor the fair, effective, and efficient delivery of justice to fit each individual case.

For citizens to trust the judicial system they must believe that justice is truly for all. The courts are a fundamental government service and should be easily accessible by the public. The Department's recently revised mission, vision, and values below embodies the important work of courts and probation and their fundamental function in Colorado.

The Judicial Department works to provide equal access to justice, contribute to public safety, and strengthen the rule of law across Colorado. Together our courts and probation departments are committed to impartial and timely dispute resolution; support for families, litigants, and victims; client rehabilitation; and meaningful community engagement.

STATUTORY AUTHORITY: The authority for Colorado's Courts is at Article VI, Colo. Const. and §13-4-101, C.R.S.; and for Probation Services is at §§18-1.3-201 and 18-1.3-202.

Major Functions of the Department

COLORADO SUPREME COURT

The Colorado Supreme Court is the state's court of last resort. Decisions are binding on all other Colorado state courts. The Supreme Court is composed of seven justices who serve ten-year terms, and the Chief Justice is selected from the membership of justices. The Chief Justice also serves as the executive head of the Colorado Judicial System and is the ex-officio chair of the Supreme Court Nominating Commission. The Chief Justice appoints the Chief Judge of the Court of Appeals and the Chief Judge of each of the state's 23 judicial districts (including Denver Juvenile and Denver Probate, which are separate courts in the 2nd Judicial District, each with their own Chief Judge) and is vested with the authority to assign judges (active or retired) to perform judicial duties.

Requests to review decisions of the Colorado Court of Appeals constitute a majority of the Supreme Court's filings. The Supreme Court also has direct appellate jurisdiction over cases in which a statute has been held to be unconstitutional, cases involving decisions of the Public Utilities Commission, writs of habeas corpus, cases involving adjudication of water rights, summary proceedings initiated under the Election Code, and prosecutorial appeals concerning search and seizure questions in pending criminal proceedings. All of these appeals are filed directly with the Supreme Court, and, in these cases bypass the Court of Appeals. The Supreme Court also has exclusive jurisdiction to promulgate rules governing practice and procedure in civil and criminal actions.

Colorado's attorneys are licensed and disciplined by the Supreme Court. The court's attorney regulation system, funded by attorney registration fees, helps the Colorado Supreme Court regulate the practice of law in Colorado through various programs. The office oversees attorney admissions, attorney registration, mandatory continuing legal and judicial education, attorney diversion and discipline, regulation of the unauthorized practice of law, and inventory counsel. In addition, the court oversees the State Court Administrator, Board of Continuing Legal Education, and the Board of Law Examiners.

COLORADO COURT OF APPEALS

The Colorado Court of Appeals is the state's intermediate appellate court and consists of 22 judges who serve eight-year terms. The Court sits in three-member divisions to decide cases. The mission of the Court of Appeals is to provide the citizens of Colorado with clear, impartial, and timely resolutions of appealed orders and judgments as provided by law. The Court of Appeals has initial jurisdiction, with exceptions, over appeals from the Colorado District Courts, Denver Probate Court, and Denver Juvenile Court. In addition, the Court of Appeals has appellate jurisdiction over decisions originating from several state administrative boards and agencies. Review of the Court of Appeals' decisions are directed to the Colorado Supreme Court.

COLORADO TRIAL COURTS

Established pursuant to Article VI of the Colorado Constitution, Colorado's state trial courts consist of county courts, district courts, and water courts. Colorado is divided into 23 judicial districts. District boundaries generally align with county borders; however, except for four districts, most districts are

comprised of multiple counties. There are currently 201 district judges serving within Colorado's 23 judicial districts. District judges preside over felony criminal matters, civil claims in any amount, juvenile matters (including adoption, dependency and neglect matters, juvenile delinquency, and paternity actions), probate, mental health, divorce proceedings, and water cases. Additionally, district judges handle appeals from Colorado municipal and county courts, and review decisions of some administrative boards and agencies. Within the 2nd Judicial District, Denver Juvenile and Denver Probate courts operate independently from the District Court. These two courts have limited jurisdiction over juvenile and probate matters respectively.

Colorado's county courts serve the citizens of each county in the state. County judges handle cases involving serious public safety issues such as misdemeanor cases, felony advisements, setting bonds, and preliminary hearings. There are 115 county court judges. County judges also issue restraining orders in cases involving domestic violence arrest, issue search warrants, and preside over traffic cases and civil actions involving no more than \$25,000.

The Water Right Determination and Administration Act of 1969 created seven water divisions according to drainage patterns of various rivers in Colorado. Each water division is staffed with a division engineer, appointed by the state engineer; a water judge, appointed by the Supreme Court; a water referee, appointed by the water judge; and a water clerk, assigned by the district court. Water judges are district judges appointed by the Supreme Court and have jurisdiction in the determination of water rights, the use and administration of water, and all other water matters within the jurisdiction of the water divisions.

PROBATION SERVICES

Adult and juvenile probation supervision is provided in all 23 of Colorado's judicial districts. This includes 24 probation departments with over 70 separate probation offices throughout the state. Probation also provides victim services and writes presentence investigation reports for Colorado's Courts. With a continuous focus on quality, probation strives to identify and use research informed assessments, processes, and programs that enhance public safety, are cost effective, and lead to positive outcomes for the probationer and the community.

OFFICE OF THE STATE COURT ADMINISTRATOR

Colorado Courts and Probation, with more than 300 judicial officers and 3,600 staff members, is centrally administered by the Chief Justice of the Supreme Court. To assist the Chief Justice, the Supreme Court appoints the State Court Administrator (SCA). Each of the State's 23 Judicial Districts (and Denver Juvenile and Denver Probate courts) also has a Court Executive and a Chief Probation Officer, and each of the 64 counties has a Clerk of Court.

The State Court Administrator's Office (SCAO) provides administrative support and services to the trial courts, appellate courts, and probation to assist them in providing the citizens of Colorado meaningful, speedy, and economical forums to resolve disputes. It also supports the management of probation services to enhance public safety and offender rehabilitation.

In executing its constitutional and statutory duties, the office has the following functions: to provide administrative and technical support to the appellate courts, trial courts and probation; to provide

centralized policy guidance; to develop and implement standards and guidelines; to serve as an advocate in obtaining necessary resources from the legislature; to provide services in an accurate, timely and equitable manner. Business processes and technologies are consistently under evaluation for improvements throughout the Department to improve efficiency and to make the courts more accessible to the citizens of Colorado.

Principle Strategies & Goals

PRINCIPLE 1: Provide equal access to the legal system and give all an opportunity to be heard.

Barriers to access range from difficulties navigating court and probation facilities to a lack of information on how to obtain accommodations for people with disabilities or those with limited English proficiency to inadequate resources to assist self-represented parties with their procedural questions. Such barriers may compromise effective and meaningful access to the court system.

GOAL 1a. Identify and address barriers to effective participation.

GOAL 1b. Maintain safety in all court and probation facilities.

GOAL 1c. Assist self-represented parties.

PRINCIPLE 2: Treat all with dignity, respect, and concern for their rights and cultural backgrounds, and without bias or appearance of bias.

As Colorado's population continues to diversify, so does the population that participates in the court system. It is important that judges and judicial staff be aware of the values of a wide number of cultures and life experiences, and, when appropriate, make accommodations. Courts and Probation are working to ensure that the courts are free from both bias and the appearance of bias, meeting the needs of increasing numbers of self-represented litigants, remaining receptive to the needs of all constituents, ensuring that court procedures are fair, understandable and accessible, and providing culturally responsive programs and services.

GOAL 2a. Collect feedback from court users, victims of crime, and those on probation regarding their experience with court and probation services.

GOAL 2b. Train all court and probation employees in communication, cultural competency, and customer service skills.

PRINCIPLE 3: Promote quality judicial decision-making and judicial leadership.

Court practices and case management procedures should be as uniform as practicable to avoid confusion and uncertainty. Courts and Probation must provide ongoing professional development, education, and training to address many concerns including the increasing complexity of court practices and procedures in court operations and interactions with the public. Maintaining professional excellence will promote public trust and confidence in the judicial system as a whole.

GOAL 3a. Employ effective case management strategies.

GOAL 3b. Incorporate evidence-based principles in judicial decision-making.

GOAL 3c. Employ accountability methods to ensure court orders are being enforced and monitored.

GOAL 3d. Develop systems that assure court-appointed persons are providing quality services.

GOAL 3e. Train and educate judicial officers on an ongoing basis.

GOAL 3f. Implement professional development and leadership programs for staff.

PRINCIPLE 4: Implement quality assessments and community supervision of adult and juvenile probationers to demonstrably enhance public safety and respect for victim rights.

The Division of Probation Services strives to reduce offender recidivism through the application of the Eight Principles of Effective Intervention¹. Probation Services promotes accountability and responsiveness in its enforcement of the court's orders while affecting long-term behavior change in offenders.

GOAL 4a. Ensure the accuracy and efficiency of pre- and post-sentence assessments; and provide comprehensive assessment information to assist judicial officers in making more informed decisions, leading to improved and less costly outcomes.

GOAL 4b. Employ evidence-based practices in all applicable areas of probation.

PRINCIPLE 5: Cultivate public trust and confidence through the thoughtful stewardship of public resources.

In serving the people of Colorado, Courts and Probation must also exercise its constitutional and statutory authority and responsibility to plan for, direct, monitor, and support the business of the system and to account to the public for the system's performance. The fulfillment of this role is only possible when the other branches of government and the public have trust and confidence in the system. In order to retain trust and confidence, the system must be accountable to the people it serves by providing a fair and open process, communicating clear and consistent expectations for all who participate in that process, and being good stewards of the resources appropriated to it for the fulfillment of its mission.

GOAL 5a. Utilize the most effective and cost-efficient methods to conduct the business of the courts and probation.

GOAL 5b. Employ new and enhanced technology solutions for managing judicial business.

GOAL 5c. Share information and data with other governmental entities and the public, while balancing privacy and security concerns.

GOAL 5d. Ensure transparency of court and probation services operations.

GOAL 5e. Maintain a strong and well-trained workforce.

Environmental Scan

During fiscal year 2025 (FY25), the Judicial Department demonstrated its commitment to creating long-term cultural improvements within the branch by initiating or advancing efforts in several important areas. The Department began working toward the creation of a five-year strategic plan to help inform decisions regarding high-priority issues and the most prudent use of resources moving forward. The Department advocated for increased safety and security within the state's court and probation offices, invested in improving its training resources for judicial officers and staff, and advanced its effort to promote the wellness of judicial personnel. Additionally, the Department made progress in its complex and resource-intensive goal of overhauling its outdated case management system.

Compass 2030 Strategic Plan

Compass 2030 refers to the Judicial Department's five-year strategic plan which aims to provide a unified vision and framework that aligns collective efforts across the entire judicial branch. The plan will identify key priorities and objectives to address broad issues impacting the entire judicial system. A Strategic Planning Committee comprised of judicial personnel from around the state has been formed to steer these efforts and manage communication about the plan's progress to individual judicial districts. The committee intends to collect data and feedback from all judicial officers and staff to inform the Department's general priorities for the next five years. In the current environment of limited resources and uncertain funding, Compass 2030 will enable the Department to focus on its highest priority issues, ensuring that they receive appropriate attention and investment.

An important goal of the Department's strategic planning efforts is to ensure adequate resources are in place to sustain the workload on a long-term basis. A step in that direction was the passage of Senate Bill 25-024, which established 15 new judgeships effective in FY26 and FY27 to provide critically needed resources to understaffed county and district court benches across the state.

The Department secured funding for the FY26 judgeships upon the passage of SB25-024 and has submitted a budget request for full funding for the judgeships that will become effective in FY27. Despite the judgeships created by SB25-024, Colorado's county and district courts remain understaffed. While the Department did not request new judgeships in its FY27 budget request, the intention is to continue advocating for resources in the future to maintain the health and sustainability of the state's court system.

Adjacent to the strategic planning efforts, the Department intends to update its SMART Act performance measures, which have been in place since the Act's implementation. The effort to update these principles is necessary to ensure they are aligned with the Department's mission, vision, and values as well as measuring the appropriate benchmarks to better reflect the work of the judiciary. It is anticipated that the reporting requirements for FY27 will reflect the Department's updated performance measures.

Judicial Safety and Security

Judicial officers along with court and probation staff are experiencing increased threats, harassment, and retaliation during the regular course of their work. In 2025 alone, judges and Supreme Court justices received at least 43 credible threats to themselves and their families due to decisions made in their official capacity. At least 6 credible bomb threats were made to courthouses across the state. Presiding over cases involving gang activity, child custody, and elections, which are frequently litigated in Colorado's courts, are especially high-risk for judicial officers and staff. As a result of the influx of threats and harassment, the safety and security of judicial personnel, their families, and members of the public who interact with the judicial system is at the forefront of the Department's priorities moving forward.

Although Colorado law requires counties to provide security for state court facilities, there continues to be security challenges in various courthouses and probation offices around the state. The Department recognizes the value in partnering with local counties to ensure the safety and security of judicial personnel and has requested funding for a security analyst position within the State Court Administrator's Office. The position will be responsible for assembling a statewide task force comprised of judges, court staff, probation staff legislators, and county representatives, among others, to develop recommendations for a statewide security plan for judicial facilities across the state. The plan will consider minimum security standards to ensure consistent and safe operations for each court and probation office. The work of the security analyst position in conjunction with the statewide task force will allow the Department to move toward finalizing a judicial security plan and necessary statutory changes, ensuring the safety of judicial personnel and members of the public within court and probation facilities. The position will then work with legislative, judicial district, and county personnel to implement the approved recommendations.

Workplace Culture Initiative (WCI)

The Judicial Department's Workplace Culture Initiative (WCI) is a coordinated effort between the Supreme Court, State Court Administrator's Office, and each judicial district across Colorado to create long-term cultural improvements within the state's judiciary. The Department recognizes that in order to deliver justice fairly and effectively, the workplace must be an environment where personnel feel empowered, respected, and connected to the judiciary's mission, vision, and values. In FY25, the Judicial Department made notable progress on two important WCI initiatives:

- The Manager of Leadership and Culture position was established and filled. This position leads and implements diversity, equity, inclusion, and accessibility (IDEA) initiatives across the branch and supports the various committees that are doing important work to advance the WCI's goals.
- The Department successfully created and rolled out a Safe Reporting System, which allows employees to anonymously report any action that does not align with the Department's values or policies. The system provides an avenue to express concerns directly to Human Resources and reinforces the Department's commitment to establishing a safe, respectful, and inclusive environment.

The WCI's work will continue to be carried out by various working groups focusing on subsets of workplace culture matters such as training, code of conduct, employee well-being, and communications.

As part of the effort to improve its workplace culture, the Department has committed to promoting and supporting the well-being of all judicial personnel. A Judicial Well-Being Committee comprised of county, district, appellate, and Supreme Court judicial officers was formed to direct efforts in areas such as connection, support, and community building, safety and security, as well as education related to well-being resources. The Department also supports THRIVE, which is a wellness program for all judicial employees that offers training, networking opportunities, and a yearly summit event to foster a culture of caring for yourself and others. Topics addressed by THRIVE include physical safety, de-escalation, burnout, resilience, secondary trauma, and crisis management.

Judicial Department Training Efforts

In response to the need for increased attention and resources dedicated to training for judicial officers and staff across the state, the Judicial Department established the Statewide Training and Development Committee. This Committee is comprised of various positions across the trial courts, probation, and State Court Administrator's Office and was formed with the goal of fostering a culture of continuous learning, growth, and development. During FY25, the committee conducted a survey of judicial employees to identify high-priority training needs. Additionally, the committee completed the first Training Education Master Plan, which seeks to unify training priorities across the state and ensure the Department is equipped to meet the evolving training needs of staff.

Numerous units exemplify the Department's mission to provide impactful and meaningful training resources to all judicial personnel. Below are some highlights from different areas within the Department:

- The Department's Court Services Education Unit, which facilitates in-person and online classroom style training, conducted approximately 500 classes reaching over 6,000 participants across all 64 counties in Colorado. Areas of focus included court practices, procedures, and public service interactions.
- The Department's Division of Probation Services' Professional Development Unit, which provides training to probation officers, supervisors, and support staff around the state, successfully onboarded 116 new probation staff statewide during FY25. The unit is continuing its work to enhance leadership development opportunities, to increase access to training resources throughout the state, and to further align courses with instructional design best practices.
- The Department's Distance Learning Team, which focuses on creating on-demand training content, created or updated more than 30 courses throughout FY25. A significant portion of their work over the past year included adapting previously created content to be compliant with the state's digital accessibility laws and Web Content Accessibility Guidelines.
- The Judicial Officer Education unit, which provides judicial officers with educational training and programming, coordinated numerous programs and conferences during FY25. Some notable events during the past year include the Violence Against Women Act Institute, Colorado Institute for Faculty Excellence in Judicial Education, the annual judicial conference, and judge orientations for both new and experienced judicial officers.

- To address on-the-job training needs for staff in courthouses around the state, the Department has heavily invested in the Peer Training Specialist program, which provides task-based process and procedural guidance to new and tenured trial court employees. During FY25, the program expanded to employ 41 peer training specialists serving across 20 judicial districts and the Court of Appeals.

Case Management System Modernization Update

The Judicial Department is fully committed to creating a modern case management system (CMS) designed to meet the evolving needs of courts and probation departments. As the mission-critical platform for managing and tracking cases throughout their lifecycle, this new CMS will be an essential tool for streamlining operations, improving efficiency, and enhancing access to justice. The process to build a new CMS has spanned several years and work toward accomplishing this goal continued during FY25. Earlier this year, the Department completed a comprehensive assessment of its data and workflows across all judicial districts. This included documentation of business processes, data flow diagrams, and current system mapping.

The next phase of the project is to develop a procurement strategy around a strategic roadmap that will include which components of the CMS system are included as part of the initial implementation and in what order they will be completed. The Department will be working with an industry-leading IT advisory consultant who will help build this strategy, as well as creating an organizational readiness assessment, conducting a market analysis, and developing the requirements for the next phase that will be used to procure a new system. This effort will lay the foundation for a new CMS that will transform court and probation operations and support the Judicial Department's mission to provide equal access to justice across Colorado.

Management Strategies and Measurements

Trial Courts

New Case Filings Overview

New county court case filings grew by 8% compared to FY24. Every case type increased except felony complaints, which saw a slight decrease. The largest increases were noted in civil, traffic, and infraction matters.

Excluding distraint warrant and rule 120 cases², new district court case filings increased slightly compared to FY24. The most notable increase was district civil cases, which increased by 7%. The Department also noted increases in domestic relations and probate case filings. With the exception of mental health filings, all other case classes remained relatively stable compared to FY24.

² Distraint warrant and rule 120 cases require significantly fewer judicial resources to process, and new filing numbers can vary greatly year over year. These case types are often separated from year over year filing data comparisons to provide a more accurate representation of trial court work.

Trial Court Management Strategies

Case Timeliness Standards

Chief Justice Directive 08-05 outlines benchmarks for the timeliness of case resolution in the trial courts. The tables below reflect the percentage of cases that remain open past the Department's self-imposed benchmark. The Department is pleased to report improvement in the timeliness of processing certain case types such as DUI/DWAI, traffic, and dependency and neglect (child over 6 years old). However, the data indicates that the Department continues to fall short of the target benchmark in all case types except DUI/DWAI. This is due in large part to the understaffing of Colorado's county and district court benches, as indicated by the Department's weighted caseload models.

Court User Survey

The court user survey is another ongoing measure the Department uses to assess the performance of the trial courts. The survey focuses on procedural fairness, service quality, and ideas for actionable improvements. During FY25, the Department received 1,787 survey responses.³ Survey respondents included parties, attorneys, witnesses, jurors, law enforcement, observers, and others.

Questions included several 5-point Likert-style questions which are represented in table 7 below. Most court users were satisfied with the courts, with 72% of court users providing positive responses. During FY25, the average procedural fairness score was 3.88 out of 5 and the average service quality score was 3.93 out of 5, indicating a general sense of satisfaction among court users. Courts performed exceptionally well in areas such as understanding the needs of the public, providing prompt assistance, and making resources available.

Probation Services


Probation is the largest corrections agency in the state, supervising just over 67,000 adults and juveniles each year. Probation serves as an alternative to incarceration, allowing individuals to remain in their homes, jobs, and school while under court supervision. Probation is often confused with parole though they are distinct. Parole is a conditional release from custody of the Department of Corrections or Division of Youth Services and applied to individuals released from prison or commitment, while probation is one of several alternatives to incarceration that the court may impose. As supervision is provided in the community, probation is a cost-effect sentencing option, with the average cost of sentencing for adults coming in at just over \$2,000 per year compared to the cost to incarcerate an individual in the Department of Corrections at the rate of approximately \$56,700 per year per inmate.

Probation services are provided in 24 departments with 76 probation offices statewide. Probation staff are state employees who operate under the authority of the Chief Judge and Chief Probation Officers in each judicial district. Probation provides a wide range of services including pre-sentence reports, supervision, and victim services in accordance with the Victim Rights Act.

- Pre-sentence reports provide the court with information about the offense, victim impact, and the defendant to help inform sentencing decisions. Probation submitted nearly 29,000 reports to the court in Fiscal Year 2025.
- On average, probation supervises about 67,000 adults and juveniles in the community, with the primary goal of reducing risk and improving pro-social skills.
- In the last Fiscal Year, Probation made nearly 18,500 initial notifications to victims and provided an additional 27,400 notifications about critical events.

Over the last decade, probation has experienced a shift in the complexity of cases that are sentenced to supervision. Through several legislative initiatives, intentional efforts have been made to divert low risk individuals from deeper involvement in the criminal justice system. These efforts include the expansion of diversion programs and the reclassification of felonies and drug offenses. As a result of these efforts, the people currently on probation require different supervision, support, and services than those a dozen years ago. The graph below illustrates the differences in the adult population from Fiscal Year 2016 to 2025.

Adult Probation: Risk Level Comparison



Leadership and staff in Probation Departments report that individuals placed on probation are not only presenting with greater needs but also have more complex and disrupted stability factors such as lack of housing and food insecurity, behavioral problems, acute mental illness and substance dependence, and longer histories of failure on community supervision. These cases require greater attention and resources.

Despite changes in the probation population, termination and recidivism rates have remained relatively stable over the last decade. More than two-thirds (66%) of individuals complete probation successfully. Approximately two of every ten failures are related to a new crime, the remaining failures are related to a combination of absconding and patterns of violation behavior. Recidivism rates have also remained steady over time. Post-release recidivism is defined as a new deferred agreement, adjudication, or conviction for a misdemeanor or felony regardless of whether that release is considered successful. When looking at 1 year post release recidivism, adult rates have remained consistent, falling in the 6-9% range, which means more than 90% of individuals remain crime-free one year following probation supervision. Currently, a new recidivism definition and methodology are being implemented across criminal justice agencies. Future reports will include goals and metrics related specifically to recidivism.

While there are many ways to measure what success means in criminal justice, generally, it is challenging to gather meaningful metrics with a large and varied population. Two metrics are provided below. Specifically, the metrics examine trends over time related to outcomes.

Over the last two years, the department has participated in a multi-agency effort, in accordance with SB24-029, to identify a common definition and methodology for recidivism as well as alternate metrics

of recidivism to evaluate the effectiveness of the criminal justice system. The working group's efforts are scheduled to conclude in 2026.

Summary

During FY25, the Department invested heavily into improving the workplace culture of the state's judiciary and planning for its future. The investments made during the past year in the areas of strategic planning, training improvements, promotion of judicial officer and staff well-being, safety, and technology, are expected to create long term cultural benefits within the judiciary, which will enable the Department to continue exemplifying its mission, vision, and values.

Total Cases Filed

This is only for the first petition filed into the case, meaning if the petitioner files a petition for temporary extreme risk and then files an extreme risk petition in the same case, this would only be counted under the temporary petition for extreme risk since that was the first petition in the case.

Total Orders Issued and Denied

This is the total number of cases with an order for temporary extreme risk or extreme risk protection order that was issued or denied. Please note a case may have both a temporary and an extreme risk order issued/denied at separate times on the case. Therefore a case may be counted under each category.

Special Note: A petitioner may petition for an extreme risk order, but the Judicial Officer may decide to issue a temporary extreme risk order. The petitioner may petition for a temporary extreme risk order, but the Judicial Officer does not grant or deny that request at the initial hearing. The Judicial Officer does determine an extreme risk hearing should happen. At the extreme risk hearing an extreme risk protection order is granted (and a temporary order was never granted on this case). A case may also have a temporary extreme risk order granted and later have the extreme risk order granted in the case. This may cause the petition numbers to not align with the order numbers.

Total Orders Terminated

This is the total number of cases with an order for temporary extreme risk or extreme risk protection order that were vacated. A case may have a temporary and an extreme risk order vacated.

Total Orders Renewed

This is the total number of cases with an extreme risk protection order that was renewed.

New Criminal Case Filed 30 Days After Extreme Risk or Temporary Extreme Risk Granted

This displays any temporary extreme risk or extreme risk protection order case where within 30 days of issuance of the order a new criminal case was filed. The 30 days is based on the offense date for the criminal case. If a case has been sealed or suppressed it will not be included in the list.
