UNOPPOSED MOTION FOR ONE-WEEK EXTENSION OF TIME TO SUBMIT PROPOSED CASE MANAGEMENT ORDER	

Respondent, Hon. Ian James MacLaren, through his counsel Jane B. Cox and David M. Beller of Recht Kornfeld, P.C., submits this Unopposed Motion for One-Week Extension of Time to Submit Proposed Case Management Order (“Motion for Extension of Time”). In support, Respondent states as follows:

Certification of Conferral Pursuant to C.R.C.P. 121 § 1-15(8): Counsel for Respondent conferred with Special Counsel for the Colorado Commission on Judicial Discipline (“the

Commission”) via telephone regarding the requested extension of time. Special Counsel confirmed in writing that the Commission does not oppose the requested relief.

1. On March 5, 2026, the Adjudicative Judicial Discipline Panel (“the Panel”) entered its Order Regarding Respondent’s Objection Regarding the Colorado Rules of Judicial Discipline and Order Regarding Submission of Case Management Order (“Order re: CMO”).

2. The Order re: CMO orders the parties to exchange proposed Case Management Orders within seven days (which fell on or about March 12, 2026), and to confer regarding the proposed orders in an effort to resolve any disputes and submit either an agreed-upon CMO or their respective disputed CMOs within seven days.

3. The seven-day conferral period elapses today, March 19, 2026.

4. Concurrently with this Motion for Extension of Time, undersigned counsel submits a Substitution of Counsel for Respondent.

5. Counsel were retained on March 18, 2026, to assume representation of Respondent in this proceeding. Counsel is not yet in possession of the exchanged proposed CMOs, but is working with former counsel and Special Counsel’s full cooperation to obtain those materials.

6. Undersigned counsel respectfully requests an extension of one week, to and through March 26, 2026, in which to review the proposed CMOs, confer with Special Counsel, and to submit the agreed-upon or disputed CMO.

7. Respondent makes this request for a brief extension of time not for any improper purpose, but solely to afford his new counsel sufficient opportunity to assess the case and adequately participate in the drafting of the proposed CMO.

8. Neither party nor the Panel shall be prejudiced by this brief requested extension of time. This request is being made in good faith and is not being interposed for purposes of delay.

WHEREFORE, Respondent, Hon. Ian James MacLaren, respectfully submits this Motion for Extension of Time, and asks the Panel to enter an order allowing the parties an additional week, to and through March 26, 2026, in which to confer and submit an agreed-upon proposed CMO or their respective disputed proposed CMOs for the Panel's consideration.
