a) Legislation Updates (updated) (Bill Effective Date)

Below is a list of some legislation going into effect and a summary of form changes.

Note: While the goal is to publish forms on the bill's live date, due to volume, new approval procedures, and accessibility remediation time, it may take several weeks/months for the updated form to be published. The outdated version of the form may be unavailable until then.

- HB25-1159 – Child Support Commission Updates March 1st, 2026
 - Updates to how child support is calculated.
 - *JDF 1820 Support Worksheet A* is discontinued.
 - JDF 1821 is now “Support Worksheet” and is amended to accommodate new calculations.
 - *JDF 1822 Child Support Guidelines* is discontinued.

- HB25-1185 – Child Conceived from Sexual Assault August 2025
 - Creates a process to terminate the Respondent’s parental rights.
 - Petitioner can request relinquishment with fewer requirements than the standard relinquishment process.
 - New Petition created; JDF 452 B.
