a) Legislative Project Updates (Bill Effective Date)

Below is a list of some legislation going into effect and a summary of form changes.

SB26-004 **Extreme Risk Protection Orders** **April 6th**

- This bill expands the list of those who can be a petitioner.
- Project Status: Phase 4 – Seeking Approval
- Estimated project completion: Early Q3 2026.

SB26-061 **Publication in Counties w/o Newspaper** **August 12th**

- Allows legal materials by publication in an adjoining county if the base county doesn't have a qualifying newspaper.
- Project Status: Phase 1 - Drafting
- Estimated project completion: Late Q3 2026.

SB26-149 **Competency** **On Signature**

- Sample orders (instead of JDFs) will be drafted and posted on the JRM as a resource for Judicial Officers.

HB26-1110 **Vulnerable Adult & Disbursements** **August 12th**

- Allows a Petition to stop suspicious disbursement involving vulnerable adults.
- Project Status: Phase 0 – Pre-Development
- Estimated project completion: Q4 2026.
