COUNT 1-MURDER IN THE FIRST DEGREE (F1)

Between and including December 18, 2023 and December 19, 2023, Kimberlee Singler unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than herself, caused the death of _____ ; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 2-MURDER IN THE FIRST DEGREE (F1)

Between and including December 18, 2023 and December 19, 2023, Kimberlee Singler unlawfully, feloniously, and knowingly caused the death of _____ a child who had not yet attained twelve years of age, and the defendant was in a position of trust with respect to the victim; in violation of section 18-3-102(1)(f), C.R.S.

COUNT 3-MURDER IN THE FIRST DEGREE (F1)

Between and including December 18, 2023 and December 19, 2023, Kimberlee Singler unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than herself, caused the death of _____ ; in violation of section 18-3-102(1)(a), C.R.S.

COUNT 4-MURDER IN THE FIRST DEGREE (F1)

Between and including December 18, 2023 and December 19, 2023, Kimberlee Singler unlawfully, feloniously, and knowingly caused the death of _____ a child who had not yet attained twelve years of age, and the defendant was in a position of trust with respect to the victim; in violation of section 18-3-102(1)(f), C.R.S.

COUNT 5-CRIMINAL ATTEMPT TO COMMIT MURDER IN THE FIRST DEGREE (F2)

Between and including December 18, 2023 and December 19, 2023, by engaging in conduct constituting a substantial step toward the commission of murder in the first degree, Kimberlee Singler unlawfully, feloniously, after deliberation, and with the intent to cause the death of a person other than herself, attempted to cause the death of _____ ; in violation of sections 18-3-102(1)(a) and 18-2-101, C.R.S.

COUNT 6-CRIMINAL ATTEMPT TO COMMIT MURDER IN THE FIRST DEGREE (F2)

Between and including December 18, 2023 and December 19, 2023, by engaging in conduct constituting a substantial step toward the commission of murder in the first degree, Kimberlee Singler unlawfully, feloniously, and knowingly attempted to cause the death of _____ a child who had not yet attained twelve years of age, and the defendant was in a position of trust with respect to the victim; in violation of sections 18-3-102(1)(f) and 18-2-101, C.R.S.

COUNT 7-ASSAULT IN THE FIRST DEGREE (F3)

Between and including December 18, 2023 and December 19, 2023, Kimberlee Singler, with intent to cause serious bodily injury to another person, unlawfully and feloniously caused serious bodily injury to _____ by means of a deadly weapon, namely: Knife; in violation of section 18-3-202(1)(a), C.R.S.
