

**ADMINISTRATIVE ORDER 2008-06
CONCERNING THE DIVISION OF THE CASELOAD OF THE DISTRICT COURT
AMENDED AND EFFECTIVE July 15, 2026**

The Chief Judge is delegated the responsibility to divide the caseload and assign the cases filed in the District and County Courts of the Seventh Judicial District to its judicial officers pursuant to Chief Justice Directive 95-01. All case assignments, except as noted below, are done by the Chief Judge or as delegated to the Court Executive. To determine and establish this caseload division and general case assignments, the Chief Judge receives information regarding the types and number of cases filed in each location, and the Chief Judge considers information from other judicial officers in the district. To the extent feasible, cases are assigned geographically, taking into account the residence of each judge, the number of courtrooms and chambers in each courthouse, and weighted caseloads. Case assignments are intended to be fair, efficient, and to serve the needs of community.

Order

The District Court case assignment as of July 15, 2026, is attached.

Assignments of District Judges and Magistrates to cases other than as indicated in the attachment shall be done by the Chief Judge or as delegated to the Court Executive.

County Court cases in every county of the Seventh Judicial District are assigned to the County Judge appointed and presiding in that county.

Assignments of County Judges to cases or dockets outside their county or to District Court cases shall be done by the Chief Judge or as delegated to the Court Executive.

The assignment of cases in the event of a recusal is set by Administrative Order 26-03.

This case assignment may be implemented in phases or over a period of transition as may be directed by the Chief Judge or as delegated to the Court Executive.

The Court Executive shall annually collect and report the district's case filing data to the Chief Judge to facilitate a regular update to this case assignment.
