

Domestic Relations (DR) Divisions Setting Information for El Paso County

(Revised 8-3-2026 and Effective 8/10/2026)

Instructions: Complete the Notice to Set for Uncontested or Default Final Orders Hearing (Pro Se) (FCF 1015) to set an uncontested hearing with a Magistrate in Divisions: L, M, R, X, and Y. Parties *do not* need to call the division. The division will send a notice of hearing to the parties with the day, time, and directions on how to appear (in person or Webex). **Instructions: Complete the Notice to Set Hearing for Contested Final Orders (JDF 1123)** to make an appointment with the division staff to set your case for a contested hearing before the Judge assigned to your case. Parties will also need to schedule and attend mediation. On the day and time, you selected, contact the Division listed on the form. Be sure to include your name, phone number, and case number; your call or email will be returned. Once you receive your hearing date, complete and sign the Notice of Hearing (JDF 1124). **Instructions: Complete the Notice to Set Hearing for Contested Post Decree Hearing (JDF 1123).** Same instructions as setting for contested final orders.
